4. Trainer Eligibility Criteria

- Eligibility Requirements:
 - Current LPG industry professionals in relevant segments (e.g., LPG Sales, Operations)
 - Minimum 15 years of experience in the relevant domain
 - Ex-employees are ineligible to conduct independent training, they may connect HSSC for their services/assignment
 - Required documentation must accompany the work order:
 - Contact No (AADHAR SYNCED)
 - E-Mail ID
 - AADHAR Card
 - Passport Photograph (Soft Copy)
 - Last Educational Certificate
 - Professional Certificate/ID Card/Any latest Document mentioning Participant name on Organization's Letter-Head
 - Profile/CV

5. Benefits of ToT Program

- Certification: Valid for 2 years for successful candidates
- Eligible as in-house trainers for LPG workforce training
- Assessment Fee: Only Rs. 400/- per workforce assessment & certification by HSSC, after the inhouse TOT trainer's certification

6. Process of Nominations

- Nominations Steps:
 - Submit work order on organisation letterhead with nominated participant documents (per eligibility criteria in point 4)
 - Upon confirmation from HSSC, provide trainer ID and advance payment receipt
 - Register participants using the provided link and submit trainer ID
- 7. Post-ToT Workforce Training by Certified Trainers inhouse and certification by HSSC
 - Required Documentation for Workforce Training:



- **Data**: Submit participant data and latest photograph (soft copy) 10 days before training date for registration of participant with HSSC
- **Purchase Order (PO)**: Submit PO with document of participants 10 days prior to the training date
